NOW THEREFORE, the parties freely and fully accept the provisions, terms and conditions hereof and in consideration of the promises and mutual covenants herein contained as well as for other good and

valuable considerations not herein specifically set forth, the parties do hereby agree to the following:

1. Premarital Property. (Check one)

- **17. Binding Effect.** This Agreement will inure to the benefit of and be binding upon the Parties, their successors, heirs, executors, administrators, assigns and representatives.
- **18. Severability.** In the event that any provision of this Agreement is held to be invalid, illegal or unenforceable in whole or in part, the validity, legality and enforceability of the remaining provisions shall not be affected and the remaining provisions shall be construed, to the extent possible, to give effect to this Agreement without the inclusion of such invalid, illegal or unenforceable provision.

<b>19. Governing Law.</b> The terms of this Agreement shall be governed by and construed in accordance with the laws of the State of, not including its conflicts of law provisions.

- **24. Amendment or Revocation.** This Agreement may be amended or modified only by a written agreement signed by both of the Parties. This Agreement may be revoked if both Parties sign a written agreement before the presence of a notary public or other authorized official. Revocation shall become effective when properly recorded as required by state and local laws.
- **25. Acknowledgment.** The Parties acknowledge that they have been informed of their legal rights, have been given an adequate amount of time to consider entering into this Agreement, have read and



understand this Agreement, agree with the contents of this Agreement and believe it to be fair, have no been pressured or coerced into signing this Agreement and have chosen to freely and voluntarily enter into this Agreement.
