All sections of this Limited Power of Attorney (POA) Form must be completed to be valid. All sections must be handwritten or typed. Copy of photo IDs for Grantor(s) and Grantee required. NOTE: This POA <u>cannot</u> be used in a dealer transaction to complete a title assignment on a motor vehicle subject to federal odometer disclosure. In compliance with federal law, the secure *Power of Attorney to Disclose Mileage* (Form MVT-10) must be used when use of a power of attorney is permitted by the applicable regulations for a vehicle subject to federal odometer disclosure.
